

SUMMARY ANNUAL REPORT

For Banner Health Master Health And Welfare Plan

This is a summary of the annual report of the Banner Health Master Health And Welfare Plan, EIN 45-0233470, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Banner Health has committed itself to pay certain self-insured Medical, Dental, Short-term Disability, and Employee Assistance Program claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Vision Service Plan, Metropolitan General Insurance Company, Cigna Health And Life Insurance Company And Affiliates, Reliance Standard Life Insurance Company, Minnesota Life Insurance Company, and Aetna Life Insurance Company to pay Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Legal, Critical Illness, Hospital, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$58,996,077.
